ALL PROJECTS BID PER CURRENT CDOT STANDARD PROCESS UNLESS NOTED OTHERWISE

RESURFACING PLANS:

- US 40 Winter Park Phase 1 - Grand County (26140)
- Construction budget: \$7m
- Scope: 2" depth mill/HMA MP 230 to 233, ADA ramps, Guardrail Type 3, and Bridge Joint replacement MP 223.8 (with night work)
- AD date: November 14, 2024 (4-week Ad)
- Construction timeframe: 5 months

SHOULDER WIDENING/SAFETY

- US 40 Red Dirt Hill (Phase I)- Grand County (25802)
- US 40 (MP 217 to 219) east of Granby
- Construction budget: \$7.5m
- Scope: Widening WB shoulder Uncl. Ex and Embankment, then 2" HMA overlay and restripe for 8' shoulder in each direction, full depth reclamation, Guardrail Type 3, Guardrail Type 9, striping, signing, minor drainage work, revegetation
- AD date: January 2025
- Construction timeframe: 6 months

DRAINAGE REPAIRS:

- I-70 Straight Creek Culverts- Summit County (26425)
- Construction budget: \$4.7m
- Scope: Culvert Lining, Storm Manholes, Inlets, 10' gutter pan repairs, Slope Repairs MP 206 to 213
- AD date: April 2025
- Construction timeframe: 4-5 months

2025 Asphalt Project:

Combining streets, parking lots and trails into a single project, the City has a large Asphalt project out to bid currently.

Concrete Replacement and ADA Improvement Project:

This is project that focuses on improving and maintaining concrete infrastructure in the ROW such as curb and gutter, ADA ramps, and sidewalks. This project will be posted for bid early 2025 and the work can be completed all summer 2025.

Castle Creek Bridge Underpass Retaining Wall Repair:

This project was posted for bid at the beginning of this year. Due to site constraints no bids were received. We are going to be reposting this for bid next year. This is retaining wall repair, if you have any interest or questions, please reach out.

Cemetery Lane and Snowbunny Intersection and Pedestrian Improvement Project:

This project focuses on improving the intersection of Cemetery Lane and Snowbunny for predictable vehicle movements and improved pedestrian sight lines. This project will be posted for bid in early 2025 with work during the summer.

2025 Town of Carbondale Projects

Utilities

Roaring Fork Treatment Plant – Filtration Upgrade

Scope of Work: Remove two membrane filtration units with associated equipment, instrumentation, and controls (compressors, tanks, instrumentation, and control panels). Move one pair of existing cartridge filters and install one new matching set of cartridge filters. Complete clearwell tank coating. Install all required instrumentation and controls for cartridge filtration.

Schedule: bid Winter 2024/2025, construction Spring 2025.

Wastewater Treatment Plant – Solids Handling Upgrade

Scope of Work: Install a backup screwpress for redundant sludge dewatering. The Town of Carbondale will procure major associated equipment, the Spirac and control panel, due to long lead times.

Schedule: bid Summer 2025, construction Fall 2025

Wastewater Treatment Plant – Blower and Air Control Upgrade

Scope of Work: Install an upgraded blower package and automated valve control to manage air flow to the aeration basin and digesters.

Schedule: bid Spring 2025, Summer 2025

Sanitary Sewer Replacement – 2nd Street (1000 LF)

Scope of Work: Replace approximately 1000 linear feet of sanitary sewer on 2nd Street from Snowmass Drive to Capitol Ave. Manage traffic control and maintain sanitary sewer operations during installation.

Schedule: bid Winter/Spring 2025, construction Summer 2025

Distribution System Resiliency and Maintenance:

Scope of Work: Power backups for telemetry at pressure reducing valves, storage tanks, and pump stations, repair or replace access hatches where necessary

Schedule: bid Summer 2025, construction Fall 2025

Public Works

Annual Chip Sealing Project

Scope of Work: Chip Sealing approximately 57,000 sqyds of town streets

Schedule: bid late February/early March 2025

Trail Overlay

Scope of Work: Installation of 2” HMA overlay on existing trails, approximately 500 tons

Schedule: bid late February/early March 2025

2025	Retaining Wall Replacement: 055-73-56.573001	This program is for the replacement for the replacement of existing timber walls within the roadways. This is design dollars to gain further Engineer Estimate to establish a consistent replacement program.	Design & Construction
2025	Hard Surface Trails: 055-72-55.572000	This is funding for design and construction of the next trail improvement project.	Design & Construction
2025	Bus Stop Improvement Project: 055-71-52.571404	The project funding will be used to improve aging bus stops within the Village. The goal is to improve safety, comfort, rider experience and aesthetics.	Construction

For 2025 we are looking at the following two projects:

Lower River Road Paving

Scope: 2" Overlay, spot full depth patching, culvert replacement, tree removal. From SH82 to Upper River Rd/Gerbaz Way Intersection

Budget: \$2 million

Sopris Creek Culvert Replacement

Scope: Removal of failing steel pipe, 10'x7' CBC with wingwalls, traffic and water control during construction, roadway reconstruction. Contingent on pending ROW acquisition.

Budget: \$650k

2025 Capital Construction Projects

Street Repair

Description: Two 1-block sections of street reconstruction for improved drainage and repair

Budget: Engineer Estimation of Cost = \$310,625

Timeframe: Bid date = January 1
Construction = Spring 2025

Water Line Replacement

Description: Replace 4,000 linear feet of cast iron water line with ductile iron, including all joints and services.

Budget: EEC = \$2,100,000

Timeframe: Bid date = January 1
Construction = summer 2025

- Both construction projects have engineered designs ready and available when bid opens.
- The Town of Meeker solicits bids on BidNet.
